A-30 Class Alu Bulkhead, type U SeaProtect Slab 66 - 2*30/30 mm * Restricted application *

Composed of structural 6 mm thick aluminium bulkhead insulated on exposed stiffened side with mineral wool:

- 2*30 mm "U SeaProtect Slab 66" (former "ULTIMATE U MPN 66"; nominal density 66 kg/m³) between stiffeners,
- 30 mm "U SeaProtect Slab 66" (former "ULTIMATE U MPN 66"; nominal density 66 kg/m³) wrapped around stiffeners (cavities inside stiffeners are also filled).

Fastening welded pins:

- max spacing 300 mm horizontally and vertically on plate between stiffeners,
- max spacing 150 mm around stiffeners.

A-60 Class Alu Bulkhead, type U SeaProtect Slab 66 - 2*(2*30)/30 mm

Composed of structural 6 mm thick aluminium bulkhead insulated on both sides with mineral wool:

- 2*30 mm "U SeaProtect Slab 66" (former "ULTIMATE U MPN 66"; nominal density 66 kg/m³) on exposed side,
- 2*30 mm "U SeaProtect Slab 66" (former "ULTIMATE U MPN 66"; nominal density 66 kg/m³) in between stiffeners,
- 30 mm "U SeaProtect Slab 66" (former "ULTIMATE U MPN 66"; nominal density 66 kg/m³) wrapped around stiffeners (cavities inside stiffeners are also filled).

Fastening welded pins:

- max spacing 300 mm on exposed side,
- max spacing 300 mm horizontaly and 400 mm vertically on plate between stiffeners,
- max spacing 150 mm around stiffeners.

A-60 Class Alu Bulkhead, type U SeaProtect Slab 66 - 2x30/2x30 mm * Restricted application *

Composed of structural 6 mm thick aluminium bulkhead insulated on exposed stiffened side with mineral wool:

- 2x30 mm "U SeaProtect Slab 66" (former "ULTIMATE U MPN 66"; nominal density 66 kg/m³) between stiffeners,
- 2x30 mm "U SeaProtect Slab 66" (former "ULTIMATE U MPN 66"; nominal density 66 kg/m³) wrapped around stiffeners (cavities inside stiffeners are also filled).

Steel pins with washers:

- max spacing 300 mm horizontally and vertically on plate between stiffeners,
- max spacing 150 mm around stiffeners.

A-60 Class Alu Bulkhead, type U SeaProtect Wired Mat 66 - 2*70 mm

Composed of structural 6 mm thick aluminium bulkhead insulated on both sides with 70 mm of mineral wool "U SeaProtect Wired Mat 66" (former "ULTIMATE U MWM 66"; nominal density 66 kg/m³). The cavities inside stiffeners are also filled with this insulating material.

Fastening welded pins:

- max spacing 300 mm on exposed side,
- max spacing 300 mm horizontaly and 400 mm vertically on plate between stiffeners,
- max spacing 150 mm around stiffeners.

4. APPLICATION / LIMITATION:

- 4.1 Restricted application: fire risk towards insulated side when specified under §1.
- 4.2 The following insulating materials shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:
 - "U SeaProtect Slab 66"
 - "U SeaProtect Wired Mat 66"
- 4.3 The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS:

- 5.1 The bulkheads are to be supplied by **SAINT-GOBAIN ISOVER G+H AG** in compliance with the type described in this certificate.
- 5.2 This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.
- 5.3 **SAINT-GOBAIN ISOVER G+H AG** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.

6. MARKING OF PRODUCT:

The product or packing is to be marked with manufacturer name, type, designation and fire-technical rating.

7. OTHERS:

- 7.1 It is **SAINT-GOBAIN ISOVER G+H AG**'s responsibility to inform shipbuilders or their sub-contractors of the proper methods of fitting, use and general maintenance of the approved equipment and the conditions of this approval.
